Forman Family: Loyalty Rewards Program

THESE TERMS AND CONDITIONS, REFERRED TO AS THE "AGREEMENT," INCLUDE A CLASS ACTION WAIVER AND MANDATE BINDING ARBITRATION ON AN INDIVIDUAL BASIS FOR DISPUTE RESOLUTION. SPECIFIC DETAILS ARE PROVIDED BELOW. IN THE EVENT OF A DISPUTE, YOU ARE RENOUNCING YOUR RIGHT TO INITIATE LEGAL ACTION IN COURT. In the event of the Forman Family Loyalty Rewards Program's termination, any benefits that remain unredeemed will be forfeited without any obligation or liability. Such unredeemed benefits will not be rewarded either upon termination or after the conclusion of any notice period, if required by law. We shall not be held liable under any circumstances for any delay or failure in performance resulting, in whole or in part, from acts of nature or other circumstances beyond our reasonable control.

We retain the authority to cancel or suspend your participation in the Loyalty Rewards Program or any unused Rewards earned, in the event of suspected fraud, abuse of rewards privileges, violation of these Rewards Program Terms and Conditions, or at our discretion. It is important to note that the Loyalty Rewards Program is exclusively available within the United States. Members are solely responsible for any tax liability associated with their participation in the Rewards Program.



Forman Family: Loyalty Rewards Program Terms and Conditions

1. Eligibility:

Forman Mills Loyalty Rewards Program is open to individuals aged 18 and above who meet the criteria for participation as outlined in these terms and conditions.

2. Membership:

Membership in the Loyalty Rewards Program is free and requires completion of opting into the SMS program to obtain a wallet pass. The pass must be downloaded and scanned before a transaction. For full benefits and to opt in, members must text JOIN to 50886 and agree by:

- typing in Y (for marketing materials)
- zip code

phone number will be obtained

Members are responsible for having their wallet pass scanned at point-of-sale. Any amendments to must be forwarded to rewards@formanmills.com providing:

- phone number
- first name
- last name
- modification request
- copy of receipt

3. Earning Points:

- Points are earned through qualifying purchases, data surveys, and other actions as specified by the Loyalty Rewards Program.
 - Points have no cash value.
 - Active members earn one point for every dollar spent.
 - Customers only begin earning points for transactions that are posted after the customer receives a "membership" by opting in downloading their wallet pass and having it scanned.

Non-merchandise items and/or gift cards are excluded from earning points

4. Redemption of Rewards:

Upon reaching an accumulation of 200 earned points, members are entitled to receive a \$5 Reward. A single \$5 Reward can be applied to transactions exceeding \$50+, the following day. Any remaining points, earmarked for the attainment of another reward, will be retained, and recorded for subsequent redemption during a separate transaction at a later time.

- \$1 = 1 point
- 200 points = \$5 reward
- Cap the max single reward at \$5 (\$50 minimum spend required on each)



Rewards earned within the Forman Family Loyalty Rewards Program are redeemable in accordance with the specifications outlined in promotional materials. All redemptions are contingent upon availability and may be governed by supplementary terms.

Transferring rewards to another member's account is not permitted.

5. Expiry:

Points: As per the Forman Family Loyalty Rewards Program guidelines, points expire following 365 days of inactivity. Once expired, points are irretrievable and an earned reward will be removed.

6. Modifications and Termination:

The Loyalty Rewards Program, including its terms and conditions, may be modified, suspended, or terminated at the discretion of Forman Mills without prior notice.

7. Fraud and Abuse:

Any attempt to manipulate, abuse, or engage in fraudulent activity related to the Forman Family Loyalty Rewards Program may result in the immediate termination of membership and forfeiture of all points and rewards.

8. Privacy:

Member information will be handled in accordance with our privacy policy. By participating in the Loyalty Rewards Program, members consent to the collection, use, and disclosure of their personal information.

9. Communication:

Members may opt-in to receive marketing communications related to the Forman Mills Loyalty Rewards Program and/or Forman Mills marketing, including updates, promotions, and other information. Members can opt out of non-essential communications and be able to still use their downloaded wallet pass to earn points.
